

Mastercard® Priceless Paris Experience Competition Terms & Conditions

This Mastercard® Priceless Paris Experience Competition (“Competition”) is exclusive to the members of the Sands Lifestyle Loyalty Program, co-branded by Venetian Cotai Limited (“VCL”) in collaboration with Industrial and Commercial Bank of China (Asia) Macau and Industrial and Commercial Bank of China Hong Kong (collectively “ICBC”) and administered by the service provider, Mastercard Asia/Pacific Pte Ltd and its affiliates (“Mastercard”).

Eligibility

1. This Competition is open to Hong Kong S.A.R. and Macao S.A.R. residents aged 18 or over, holding a ICBC Sands Lifestyle Platinum Mastercard card or a ICBC Sands Lifestyle World Mastercard card (“Qualifying Card”) issued by ICBC (“Sands Lifestyle Cardholders”), excluding any government officials, employees and their immediate families of Mastercard and VCL, its subsidiaries, other group companies, its agents, or anyone else professionally connected with this competition.
2. The competition will run from **19/10/2017 to 23:59 on 31/12/2017** (Hong Kong time) inclusive (“Promotional Period”).

Entry Requirements

3. Sands Lifestyle Cardholders who make a retail purchase with total transaction value of MOP 500 (five hundred) or above with a Qualifying Card at a retail store within Shoppes at Parisian during the Promotional Period (“Qualifying Transaction”) are eligible for entry into the Competition. A Qualifying Transaction is counted based on its transaction date.
4. Sands Lifestyle Cardholders with Qualifying Transactions will automatically be entered into the Competition.

Award of Prize

5. The Sands Lifestyle Cardholder who executes the highest number of Qualifying Transactions within the Promotional Period will be awarded the Mastercard Priceless Paris Experience prize.
6. In the event that one or more Sands Lifestyle Cardholders execute the same, highest number of Qualifying Transactions, the Sands Lifestyle Cardholder who executed the highest amount (in MOP) of a single Qualifying Transaction during the Promotional Period will be awarded the Mastercard Priceless Paris Experience prize.

Prize Package and Fulfilment

7. **1 x Mastercard Priceless Paris Experience** will be awarded for the Competition.
8. The prize package is for the winning Sands Lifestyle Cardholder and one additional guest aged 18 or over (“Guest”) and consists of the following:
 - 2 x round-trip business class air flight tickets to/from Hong Kong and Paris, France
 - 4-day-3-night accommodation in luxury hotel, with complimentary breakfast & Wi-Fi
 - Return airport car transfers to/from Paris airport and hotel
 - Private tour of Paris
 - Dinner at Michelin-starred restaurant in Paris for 2 people
 - Professional makeover
 - Photo shoot around Paris’ iconic sites
 - Dinner for two at Le Jules Verne Restaurant at the top of the Eiffel Tower
 - Pre-paid Mastercard with US\$500 credit
 - Transportation for all arranged activities in Paris

The itinerary and package elements are at the discretion of Mastercard and are subject to changes.

9. All other costs and expenses for the trip including, but not limited to, excursion, transit, personal spending or any additional room nights, are the responsibility of the Sands Lifestyle Cardholder.

10. Any insurance, tax (if applicable), translator or visa application costs are not included in the prize.

11. The prize cannot be transferred, exchanged for cash or any other products or services.

12. The dates of the Mastercard Priceless Paris Experience will be in April 2018, and the dates are at the discretion of Mastercard. If the Sands Lifestyle Cardholder wishes to change the dates, the Sands Lifestyle Cardholder will be responsible for any additional costs incurred as a result of change of dates. All requests for change of dates are subject to availability.

Award Notification

13. Mastercard will notify the award of the prize to the winning Sands Lifestyle Cardholder within **50 DAYS** of the close of the Promotional Period via phone. Sands Lifestyle Cardholders shall be responsible for updating their contact information recorded in their Sands Lifestyle account. The winning Sands Lifestyle Cardholder will have **7 DAYS** to accept the prize by following the instructions provided in the notification from Mastercard. Failure to follow the instructions or accept the prize within **7 DAYS** of the winning notification will result in the prize being forfeited and Mastercard may at its absolute discretion award the prize to a reserve, who is the Sands Lifestyle Cardholder with the second highest number of Qualifying Transactions during the Promotional Period. The decision of Mastercard is final.

14. There is no cash or other alternative for the prize in whole or in part except that in the event of circumstances outside of its control, and Mastercard reserve the right to substitute the prize with one of equal or greater value at the choosing and discretion of Mastercard.

Other Important Information

15. The winning Sands Lifestyle Cardholder must hold a valid Qualifying Card with good standing. The winning Sands Lifestyle Cardholder and the Guest take part in the prize at their own risk and to the fullest extent allowed by law, Mastercard and VCL accept no liability with regard to such prize or activities whatsoever. Mastercard and VCL will have no liability in relation to the conduct of the Sands Lifestyle Cardholder or the Guest, nor in connection with any circumstances outside its control, with respect to the prize.

16. Accommodation and all other products and services provided to the Sands Lifestyle Cardholder will be provided subject to the terms and conditions of each such provider. Mastercard, VCL or their agents will have no liability in relation thereto, and any dispute arising from accommodation or services must be resolved with such providers.

17. The prize is personal to the winning Sands Lifestyle Cardholder, and any sale, transfer, resale, donation, or exchange of the prize and/or part of any of the prize package is strictly prohibited (including, without limitation, online via an online auction website or online marketplace). Mastercard reserves the right to withdraw or void any and all prize elements if the Sands Lifestyle Cardholder is found to violate these terms and conditions.

18. The Sands Lifestyle Cardholder and the Guest must abide by the terms and conditions of the entry or any tickets which form part of the prize, which may be subject to change from time to time and may require presentation of valid photo ID, travel documents and/or other forms of identification. Failure to comply with any of the terms and conditions may result in the Sands Lifestyle Cardholder being refused permission to travel or entry, as applicable.

19. It is a condition of accepting the prize that the winning Sands Lifestyle Cardholder and the Guest agree to take part in publicity accompanying or resulting from the promotion or the prize without further compensation. This may include but not limited to photographs taken which may be used for publicity purposes. 20. **Sale, transfer or exchange of any part of the prize package is strictly prohibited.** Any attempt to sell, transfer or exchange the prize will result in the prize being withdrawn by Mastercard and the prize will be declared null and void.

21. Mastercard and VCL will not be held responsible for the Sands Lifestyle Cardholder and /or the Guest not redeeming the prize due to health or any other reason.

22. If there are reasonable grounds to believe that there has been a breach of these Terms and Conditions by the winning Sands Lifestyle Cardholder or the Guest, or any instructions forming part of this promotion's entry requirements or otherwise where the Sands Lifestyle Cardholder has gained unfair advantage in participating in the promotion or won using fraudulent means, Mastercard may, at its sole discretion invalidate the prize and disqualify that Sands Lifestyle Cardholder from the promotion.

23. To the maximum extent permitted by the applicable law, Mastercard and VCL and their affiliates, associated agencies and companies will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense or damage which is suffered or sustained (whether or not arising from any person's negligence) in connection with this promotion or accepting or using the prize.

If, for any reason beyond the control of Mastercard and VCL, any aspect of this promotion is not capable of running as planned, including by reason of infection by computer virus, network failure, bugs, tampering, unauthorised intervention, fraud, technical failures or any other cause which corrupts or affects the administration, security, fairness, integrity or proper conduct of this Competition, Mastercard and VCL may in their sole discretion modify or suspend the Competition. If an act, omission, event or circumstance occurs which is beyond the reasonable control of Mastercard and VCL and which prevents Mastercard and VCL from complying with these terms and conditions, Mastercard and VCL will not be liable for any failure to perform or delay in performing their obligations.

25. Sands Lifestyle Cardholders agree to release, discharge and hold Mastercard and VCL and their affiliates harmless from any and all claims including, without limitation, claims for slander, libel, defamation, violation of rights of privacy, publicity, personality, and/or civil rights, depiction in a false light, intentional or negligent infliction of emotional distress, copyright infringement, and/or any other tort and/or damages arising from or in any way relating to the participation in this Competition, the selection process, the use of the personal information, and/or the use of the Sands Lifestyle Cardholders' names, and/or likeness in connection with this Competition, or the Competition thereof in all media now known or hereafter devised.

26. Given that Las Vegas Sands Corporation ("LVSC") is headquartered in the United States of America, hotels operating under the LVSC portfolio of brands are legally restricted from conducting business with any persons or entities that are designated on the U.S. Department of the Treasury's Office of Foreign Assets Control (OFAC) List of Specially Designated Nationals and Other Blocked Persons

(including terrorists and narcotics traffickers) (the "OFAC List"), since LVSC and its affiliates could be determined to have derived income, directly or indirectly, from any such prohibited business activities. The OFAC List can be found by visiting

Participants represent and warrant that they are currently not on the OFAC List, nor on any similar restricted party listings, including those maintained by other governments pursuant to applicable United Nations, regional or national trade or financial sanctions, nor on the DICJ and/or Internal Barred Patrons List. If a participant is on any such restricted party list or is added to such restricted party list during the term of this Competition, Mastercard and VCL reserve the right to disqualify such participant if they are awarded the prize, and the prize shall not be issued or allowed to be claimed by such participant. Each participant further undertakes to notify Mastercard or VCL immediately if such participant is on or added on to any such restricted list during the Promotional Period of this Competition.

27. If any of these clauses should be determined to be illegal, invalid or otherwise unenforceable then it shall be severed and deleted from these terms and conditions and the remaining clauses shall survive and remain in full force and effect.

28. Any question concerning the legal interpretation of the rules will be based on Macau law and the Courts of Macau will have exclusive jurisdiction.

Personal Identifiable Information

29. Mastercard may collect, use, store, review, share, transmit, delete or otherwise process (collectively "process") personal identifiable information of Sands Lifestyle Cardholder, for the purposes of administering this promotion, for compliance and any other legitimate purposes as may be required, authorized or permitted by the applicable law, according to the Privacy Policy of Sands Lifestyle Program.
